Basis of Fees

We typically charge on a fixed fee basis for advice and assistance in relation to UK immigration applications.

Our fixed fee is quoted based on the following factors:

- You provide us with the necessary details and/or information and that it is all true and accurate to the best of your knowledge.

For cases to which all of the above factors apply, then the costs for our professional fee are likely to be in the region of our typical fee quotes outlined below.

If the matter becomes more complicated, urgent or time consuming than we originally anticipated and/or further representations are necessary once the application has been filed, for example further documentation is required or the application needs to be expedited, we reserve the right to charge further and in addition to the agreed fixed fee. We will inform you in advance where actual fees will exceed our agreed fixed fee.
